General Covenant Reminder:

- Homeowner Sidewalks: Please pressure wash your sidewalks. This is a homeowner responsibility.
- Mailboxes: Please pressure wash your mailboxes, and be sure the paint is not peeling or the wood decaying.
- Violation Letters: We had minimal violations this year. Thank you to all the residents who help keep our community beautiful!
 - Please understand that a letter from the HOA is not a personal attack. The Board is responsible for enforcing the covenants that we all agreed to upon purchasing our homes. The covenants are reasonable in nature. ALL covenants apply to ALL homes within our community.
- If you have any questions, you are always welcome to e-mail the Board, or contact any of the Board members. We will help however we can.

• Homeowner Association Dues: If you have not paid your dues in full, please do so immediately to avoid further finance charges. Per our covenants, past due accounts are charged 18% annual interest (1.5% monthly compounding interest). If a homeowner still does not remit payment, the HOA will lien to foreclose the property. Please note, all costs incurred are billed back to the homeowner. Avoid all of this by just simply paying your dues every year, and on time.

Board Updates:

- E-mail & Phone Numbers: We have a handful of new neighbors this year and we will be updating the directory in January. If you do not currently have your phone number or e-mail listed in the directory, and would like to have them listed, please let us know. - Rear (North) Berm: We still have a few minor issues with this berm. Please understand that any debris (natural or otherwise), objects, lawn furniture, that is on the berm will be removed at your cost. This is not a dumping site. Please help us keep out community beautiful.
- Community Entrance Sidewalks: The sidewalks were pressure washed last year and are scheduled to be done again in the Spring.
- Roads: We have been in contact with the county and continue to follow up for repaving of our roads. We will continue to work on this.
